Warranty

Premier Sealant Systems Ltd – Profiled Filler Material And Butyl Tape.

Premier Sealant Systems Ltd provide a warranty for the performance of their profiled filler material and butyl strip sealant (hereafter referred to as materials) for the time periods outlined below.

Profiled Filler Materials

Metallocene Catalysed Polyolefin (MP) 25 years +
Polyethylene (J) 20 years
EPDM Up to 25 years

Butyl Strip Sealants

High Performance Butyl Tape (DWR10/DBR10) 25 years +
General Purpose Butyl Tape (DGR30) Up To 25 years
Moisture Vapour Tape (SWRP10) 25 years

This warranty is subject to the following provisions :-

The materials shall be stored, handled and applied exactly in accordance with the design criteria and installation details stated in the Systems Manufacturers technical literature and Premier Sealants technical data sheets.

The materials shall not be subject to any substances, gases, liquids or radiation that may have a detrimental effect on them.

The specification, size and positioning of the materials in the system shall be exactly in accordance with the Systems Manufacturers technical literature and Premier Sealants technical data sheets.

The materials shall not be subjected to events, stresses or conditions exceeding the design criteria that may have a detrimental effect on them.

The structure shall be subject to regular inspections to ensure correct functioning of the drainage system.

This warranty shall be invalidated if the structure is used for purposes other than as set out in the original design should such use in any way be detrimental to the materials.

In the event of a reported material failure Premier Sealants will be given reasonable access for inspection purposes prior to any decision being made on remedial work.

If after inspection the problem is deemed to be material failure then Premier Sealants will reimburse the cost of replacement materials and the cost of labour to replace the material but not component replacement.

In the event of component failure as a result of a fault in the Sheet/ Panel Manufacturers system, or with other components supplied by third parties as part of the system, Premier Sealants will not be liable for the cost of repair or replacement of the component or material.

Premier Sealants will not accept claims for consequential loss.

Any dispute between the customer and Premier Sealant Systems Ltd concerning any matters arising from this warranty which cannot be settled by the parties to the warranty will be referred to a mutually acceptable, suitably qualified independent arbitrator. In the event of a failure to appoint an arbitrator within 14 days of written notification by either party then an arbitrator will be appointed by the President of The Institute of Arbitrators. The process of arbitration will then proceed under the direction of the appointed arbitrator.
